

How to Apply for a UNT WISE Summer Transition Program

Does the student have a disability and is between the age of 14-22?

NO

The student does not qualify if they do not have a disability and are not between 14-22

YES

[What is the student's academic status?]

Has graduated (or will graduate in May) from High School and NOT planning on post-secondary option

Still a high school student or college student

Has graduated (or will graduate in May) and WILL enroll for post-secondary option in Fall 2023

The student does not qualify if they are NOT enrolled as a student (or will not be after May)

Can qualify if the student can provide proof of Fall enrollment in a post-secondary program to the VRC

Reach out to TWS-VR to start the process to receive services by:

Is the student working with a TWS-VR Counselor?

YES

[Contact the VR Counselor to discuss the following:]

1. Inform the VRC that the student is interested in participating in a UNT WISE Summer Transition Program

2. Check to see if the student's case status has been determined "eligible" or if they are "potentially eligible"

NOTE: TWS-VR case status must be **"eligible" with an IPE in place** in order to qualify for *Live & Learn* and *College WISE*. This case status can also participate in the *Virtual Transition Program* and the *STEM Programs*

"Potentially eligible" case status would ONLY qualify for the *Virtual Transition Program* and *STEM Programs* but NOT for *Live & Learn* or *College WISE*

If case status is "potentially eligible" students can apply to Virtual Transition Program & STEM Programs ONLY.

To become "eligible" the student must provide documentation to VRC and then meet with them to develop the Individualized Plan for Employment (IPE).

If case status is "eligible" the student would qualify for any UNT WISE Summer Program. Remind the VRC to start the application when they open on 3/01/2023.

Applications open 3/01/23 and the VRC has to start the application. [Next page for application instructions]

On 3/01/2023, VR Counselors ONLY will be sent the online application link via email.



The VR Counselor will complete Part 1 of the online application and will recommend the student to the program(s) that they are a good fit for.



Once, the VR Counselor completes Part 1 of the online application, an email will be sent to the Parent/Guardian email address that the VRC inputs. The email to the Parent/Guardian will contain a login code and a link to Part 2 of the online application.



The Parent/Guardian will complete Part 2 of the application. Once the application is complete and submitted, both the Parent/Guardian and the VR Counselor will receive confirmation emails that the application was submitted.



Parents/Guardians and Students will be notified in mid to late April if they have been accepted into the program. They will receive an acceptance packet to review. Parent/Guardian must confirm acceptance.



Once acceptance has been confirmed, the student will be added to the program roster and UNT WISE will coordinate arranging funding with TWS-VR
