## Medicaid and Employment First

- Employment Assistance assistance provided to the recipient to locate paid employment in the community. This includes learning about the person's work-related capacities, locating prospective employers and facilitating a job match.
- Supported Employment intensive, ongoing support to sustain competitive, integrated employment or self-employment work in a typical work setting. This includes employment adaptations, supervision, and training related to the person's assessed needs.

### **Employment Service Training and Coordination**

- ► Training on employment services in the Medicaid waivers.
- Medicaid services must be well coordinated with schools and Vocational Rehabilitation services.



CAUTION: The Supported Employment definition in HHS is different than the SE definition in Vocational Rehabilitation!

### Medicaid

- ▶ Medicaid is health insurance.
- Provides Long-Term Services and Supports (LTSS).



# Medicaid Eligibility

Entitlement services based on eligibility.

- ► Financial status:
  - Child (under age 18) based on parental income.
  - Adult based on the income of the person.
- Person's disability.

Health and Human Services Commission.

- Medicaid State Plan Entitlement
- State Plan Amendments Not an Entitlement

# Medicaid and Managed Care

- Traditional Medicaid
- Medicaid Managed Care Programs
  - ► STAR
  - ► STAR+PLUS
  - ► STAR Kids
- CHIP Children's Health Insurance Program
- Medicaid Buy-in for children
- Medicaid Buy-in for working adults

# Step #1: Explore options to obtain Medicaid health care coverage for the child or adult.

- apply by visiting the local HHSC office and/or apply online at Your <u>Texas Benefits</u>.
- apply for CHIP, Medicaid, or Medicaid Buy-In.
- opportunity to use a waiver to obtain eligibility (name comes up on waiting list).



# Community First Choice (CFC)

Services started 6-1-2015.

- ► Eligible for Medicaid.
- Need help with activities of daily living, such as dressing bathing and eating.
- Qualify for institutional level of care.

CFC is in the State Plan - means it is an entitlement for eligible individuals.

## **Community First Choice Services**

- Personal Assistance Services (PAS) activities of daily living and routine supports.
- Habilitation assistance in learning and maintaining skills, decisionmaking, to learn how to care for themselves
- Does Not Include: Employment Assistance, Supported Employment or Transportation
- HOWEVER, many skills that assist can still be taught, practiced and supported.

#### Community First Choice and the 'Interest List'

Individuals on a Medicaid waiver "interest list" who meet eligibility and coverage requirements may be able to receive Community First Choice (CFC) services.

Services	Senate Bill 7 from the 2013 Texas Legislature requires the Health and Human Services Commission (HHSC) to put in place a cost-effective option for attendant and habilitation services for people with disabilities who have STAR+PLUS Medicaid coverage.
<ul> <li>Disability</li> <li>Financial</li> <li>Health</li> </ul>	A federal option, called Community First Choice, allows states to provide home and community-based attendant services and supports to Medicaid recipients with disabilities. This option provides states with a 6 percent increase in federal matching funds for Medicaid for these services.
<ul> <li>Clinics, Health Organizations and Resource Centers</li> </ul>	Who can get Community First Choice services?

## Step #2 - Apply for Community First Choice

- 1. Over the age of 21: Local Intellectual Developmental Disability Authority (LIDDA) or the Local Mental Health Authority (LMHA).
- > 2. Younger than age 20: Managed Care Health Provider.

Confused by the rules? Solution: Tell both!

## What is a Medicaid waiver?

The state submits program proposals to the Center for Medicaid and Medicare Services to *WAIVE* certain Medicaid program requirements, which include:

- care for people who otherwise might NOT be eligible, and
- services delivered in a different setting than the institution.

"Interest list" for Medicaid waivers.

#### Home and Community Based Services (HCBS)

The Centers for Medicare and Medicaid (CMS) designed the Home and Community Based Services (HCBS) to allow states to provide services

- ▶ in the natural home and community.
- to individuals with too much income or resources to qualify for Medicaid.

## The Texas Medicaid Waivers

▶ 7 Medicaid waivers, each with different

- eligibility criteria.
- services that are offered.
- agencies involved in eligibility and service delivery.
- All of the waivers are listed on the resource page provided for this training.
- ► Updated information on HHSC and <u>Navigate Life Texas</u>.

# Step #3 - Get your name on the Interest List for Medicaid waivers

To get a name on the Medicaid waiver interest list requires only the name of the person with the disability and adequate identifying information for future contacts. Eligibility and enrollment does not occur until the person's name comes up on the list.



### Interest List Contacts

- Contact your Local Intellectual Developmental Disabilities Authority about the Home and Community Services and Texas Home Living waiver programs. Go to the Local Authorities <u>Directory</u>.
- Call your Local Mental Health Authority about the Youth Empowerment Services (YES) waiver program. Go to the DSHS website to <u>find the Local Mental Health Authority in your</u> <u>area</u>.

#### The Community Living Assistance and Support Services - CLASS

- Services to individuals of all ages with a "related condition" and have a substantial functional limitation in at least 3 areas of living.
- ▶ Individuals live in their own home or family home.
- Provides for a wide array of direct support services, therapies and case management.

#### The Deaf Blind with Multiple Disabilities - DBMD

- Services to individuals of all ages who are deaf/blind, or have a condition that will result in deaf/blindness, and who have an additional disability.
- Provides an array of direct services, therapies and case management.
- Individuals may live in their own home, their family home, or in a residence with one to five other individuals with similar needs.

#### The Home and Community-based Services - HCS

- Provides services to people of all ages with an intellectual disability or related condition.
- Provides a wide array of direct support services, day habilitation and therapies. Service Coordination is provided by the local intellectual and developmental disability authority (LIDDA).
- Individuals may live in their own home, their family home, or a small residential setting in the community.



## The Texas Home Living - TxHmL

- Services to people with an intellectual disability (ID) or a related condition.
- TxHmL provides selected services and supports up to \$17,000 per year (a capped version of the HCS waiver).
- Services are provided by a TxHmL program provider, and service coordination is provided by the LIDDA.
- Persons live in their own home or their family's home.

#### Medically Dependent Children's Program - MDCP

- Provides a variety of services and supports for families caring for children (under age 21) who are medically dependent as an alternative to residing in a nursing facility.
- Services in MDCP are provided through <u>managed care organizations</u> through the STAR Kids and STAR Health programs.
- Services include flexible family support services, respite, home modifications and respite.

# STAR+PLUS Home and Community Based Services (HCBS) Program

Services for adults (age 21 and older) who meet eligibility for <u>nursing</u> <u>facility</u> level of care. There is a range of services including

- Covers an array of services including personal assistance, respite, emergency response, medical equipment and minor home modifications.
- Replaced the Community-Based Alternatives (CBA) waiver in 2014.

## Youth Empowerment Services - YES

Provides intensive, community-based services to children and youth with serious mental, emotional and behavioral difficulties.

- Wraparound builds on family and community support and utilizes YES array of services to help build the family's natural support network and connection with your community.
- Average length of time on the YES waiver is 8 to 16 months.
- Delivered through the local mental or behavioral health authority.

## **Consumer Directed Services**

A service delivery option that offers the individual recipient or a parent the option to be the Employer for direct support staff of selected services.

- Personal attendant support.
- Habilitation.
- Employment Assistance and Supported Employment.
